From 2021 through 2024, Virginia citizens submitted Freedom of Information Act (FOIA) requests to the Virginia Department of Elections (ELECT) and the Virginia Department of Motor Vehicles (DMV) for documents describing Driver Privilege Cards (DPC), Limited Duration Drivers Licenses (LDDL), and related topics.

DRIVER PRIVILEGE CARDS (DPC)

DPCs are given to drivers who do not have any legal presence documentation.
