Filing Procedures

Military Members applying to serve as a Delegate to the County and/or a Congressional District Convention, and/or for Membership in the Fairfax County Republican Committee (FCRC) can file at the FCRC office, 4246 Chain Bridge Road, Fairfax, VA 22030 by 12:00 NOON on Saturday, February 21, 2026. **Postmark does not count. No filings received after this deadline shall be accepted. FILINGS MUST BE LEGIBLE AND CONTAIN ALL REQUESTED INFORMATION. THE FILING FORM MUST BE ACCOMPANIED BY A LEGIBLE PHOTOCOPY OF THE MILITARY MEMBER'S VALID MILITARY ID CARD OR OTHER PROOF OF ACTIVE DUTY STATUS.** As defined in Art II, Sec. 25 of the Republican Party of Virginia Plan of Organization, a "Military Member" is "any member of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard, who is currently serving on active duty or who expects to be on active duty at the time of a particular mass meeting or convention." Illegible, incomplete, or invalid filings and any altered or changed reproductions of this Military Member Official Filing Form, will be subject to rejection and accompanying fees will be deemed contributions to the FCRC.
